**THE CORE OBJECTIVE:** - Is to promote Make, Bake and Grow produce or products.

### NATIMUK IS SITUATED:

In the Wimmera region – approximately 25kms west of Horsham, on the Wimmera Highway. It is a town of approximately 530 residents – a great mix of salt of the earth farmers, young families, rock climbers and artists. During public holidays and festival weekends, the population of Natimuk swells. Rock climbers flock to Mt Arapiles from across Australia and overseas, and of course, neighbour's, friends and family come together to reconnect also at these times.

### CONDITIONS and REQUIREMENTS: -

- **INSURANCE is required:** - We offer **No** product liability under any circumstances.
- **Stall holders with ABN number:** - must have own insurance.
- **Market fee “including insurance”:** - has a **\$1500** excess per claim.
- Labels must display a business name and ABN, and include ingredients, production method, **weight, price, contact details and warnings such as “contains nuts”.**
- The Market Management will make final decisions regarding products being appropriate to this market and site positions.
- We are committed to caring for our environment. We encourage stallholders to consider packaging products in recycled or recyclable materials, and to discourage use of plastic bags.

### STALLS

Maximum size is 3m x 3m unless previously negotiated. Powered sites are available on request.

### SETTING UP YOUR STALL **Set Up:** 8.30am - 9.45am

You are required to provide your own trestle table, gazebo/tent, weights, buckets, water, (Natimuk water is not safe to drink,) power cords etc. Note - power cords to be tagged by an authorised electrician.

Basic site OH & S checks will be carried out at the start of each market (eg no trip hazards, unstable structures etc). Shade and rain cover are your responsibility and **must be secured**.

**GAZEBOS: All Gazebos etc must be weighted down securely with appropriate weights**

We will collect one item from each stallholder to be donated to the Raffle.

Proceeds go towards promotions and publicity costs of the Market.

### HEALTH and COUNCIL REQUIREMENTS

- If applicable, please obtain a Food Act Licence from Horsham Rural City Council ([www.hrcc.vic.gov.au](http://www.hrcc.vic.gov.au))
- If applicable, please obtain a limited liquor license.
- All value-added products must have been produced in a registered kitchen. Stallholders must have completed the food safety programme. For more information, please contact Environmental Health Officer, Horsham Rural City Council on Phone: (03) 5382 9768.
- Please ensure that you bring all relevant certificates to each market – we will need to sight these or email a copy with registration form.
- All vendors selling food must be registered with either HRCC or Registered on the state-wide system **Foodtrader online** and submit a Statement of Trade to HRCC. Contact: Environmental Health Officer HRCC, PO Box 511, Horsham Vic 3402 or fax to (03) 5381 1111 or Ph: (03) 5382 8768 to discuss requirements.

**MARKET MANAGEMENT** (The Natimuk Agricultural and Pastoral Society) has the right to cancel your stall registration if all the above requirements, terms and conditions are not met.
